IMPORTANT

Attached is your IFTA license. You are required to make legible copies of the license so that one copy is carried in each qualified motor vehicle. Improper use of the license or the decals by the licensee may be cause for revocation of the license.

The IFTA decal must be visible and placed on both sides of the exterior portion of the cab (buses may place the decal on the driver's side). Failure to possess a copy of the license in the vehicle and/or to display the decals in the required location may subject the vehicle operator to the purchase of a trip permit, a citation or both.

You are required to file quarterly tax returns with West Virginia State Tax Department as long as you possess an IFTA license and decals. Tax returns are required even if no operations were conducted or no taxable fuel was used during the tax reporting period. If you cease operations, you must notify the Tax Department and return all decals to the Division of Motor Vehicles. Failure to file returns when no tax is due will result in a \$50 penalty per month for each month the return is not received. Failure to file when there is tax due will result in penalty of 10% of the net tax due or \$50 whichever is greater for each month the return is not received. If returns are not filed, you will not be able to renew your IFTA credentials in the future. In addition, your IFTA credentials may be revoked by the Division of Motor Vehicles.
